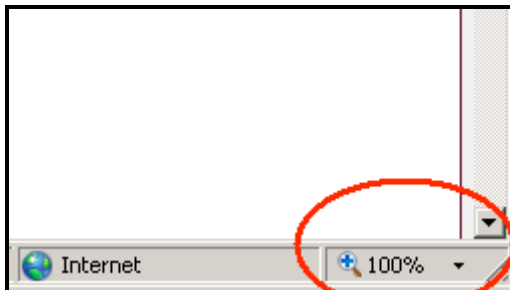

## Examples of conscious UD

In Internet Explorer 7 (IE7), a Zoom feature in the lower right corner of the screen has a pull-down menu that lets you modify the displayed text size:



In both IE7 and earlier versions, text size can be modified via a View menu → Text Size option and a Tools menu → Internet Options → Appearance → Fonts preference, but these are dependent on websites being coded properly. Even UD can be improved!

## UD control panels - Windows

### UD utilities - Windows

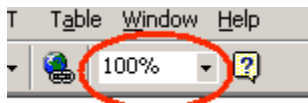
In Windows Vista, presentation of most UD control panels and utilities was moved to a centralized “Ease of Access” feature. Ease of Access can be reached by going to Control Panel→Ease of Access→Ease of Access Center, or by pressing Windows Logo Key+U.

Other UD control panel options will be discussed during the “Accommodating Boomers” webinar on October 7. Potential conflicts and resolutions between control panels and security software will be discussed during the “IT Staff” webinar on November 19.

## UD in Microsoft Office

In Word 2007, the Zoom feature is in the center of the View ribbon, and the Insert Object is in the Text section of the Insert ribbon (second option from the right).

In earlier versions of Word, the Zoom feature is under the View menu and is also available on the Formatting toolbar:

## UD control panels – other systems

Macintosh computers running most versions of OS 10 have a “Universal Access” control panel under System Preferences. VoiceOver in OS 10.5 is a major improvement over prior versions. For information on Universal Access options, see <http://www.apple.com/accessibility/>

## Websites

The two major guideline sets on website accessibility are:

- § 1194.22 of Section 508 of the Rehabilitation Act of 1973 (generally referred to as “Section 508”), [www.section508.gov/index.cfm?FuseAction=Content&ID=12#Web](http://www.section508.gov/index.cfm?FuseAction=Content&ID=12#Web).
- The Web Content Accessibility Guidelines 1.0 (WCAG), <http://www.w3.org/TR/WCAG10/>

At present, Section 508 is roughly a subset of WCAG. Both guideline sets are undergoing a significant revision, in large part to take Web 2.0 technologies into consideration, although it is unclear when the final revised versions will be published.

While there are several tools available to check for website accessibility, website review by individuals with disabilities is also critical. For example, automatic accessibility checkers can verify the existence of alternate text for a graphic, but cannot verify whether this text is appropriate.
